

# COOKIES POLICY

## 1. INTRODUCTION

- 1.1 Cookies are small text files that we store on your device in accordance with this policy. Cookies are stored on your device when you access most websites on the internet or open certain emails. Amongst other things, cookies allow a website to recognise your device and remember if you've been to the website before. We use the term cookie to refer to cookies and technologies that perform a similar function to cookies. Cookies can be read by the originating website on each subsequent visit and by any other website that recognises the cookie.

  - 1.2.2 **you** means the person accessing and using the Website (as defined below); and

- 1.3 The Website uses cookies to make the Website easier to use, to support the provision of information and functionality to you, as well as to provide us with information about how the Website is used.
